Grocery workers who are part of UFCW Local 663 have filed several ULP charges against UNFI Cub. The employer's alleged illegal behavior can keep members from winning a good contract that values their work, their families, and the many sacrifices they made in order to keep Minnesotans fed throughout the pandemic. But it won't work.

Smaller, local owners of the Cub Foods stores listed in the yellow column have already negotiated in good faith, and our members have ratified strong contracts with them.
